- 8. Special arrangement for women.
- 9. Atal Innovation Mission will be established to promote talent of youths. Also have a plan to give awards on national level to innovation.
- 10. PPP Modal have been included in it numbers 35.
- 11. To enhance biotechnology, government would give 100 crore for starting 7 research centers.
- 12. Innovation course will be started for students. Ten lakh pupils form 5 lakh schools will be benefited.

So such types of facilities are available under this scheme.
